Dr. Terry M. Saul, Superintendent, presented information on the 2024-2025 staff survey.

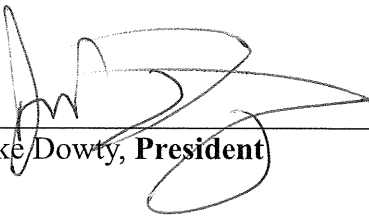
Dr. Terry M. Saul, Superintendent, presented updates on construction projects, including elementary, cafeteria, field houses, admin building and elementary playground.

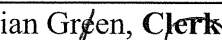

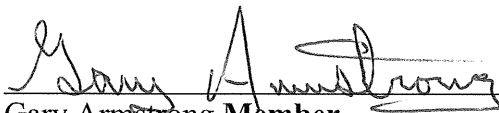


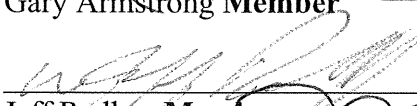
